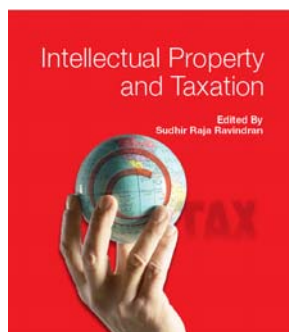


## Intellectual Property and Taxation – Edited By Sudhir Ravindran
